More information about the use of cookies

. In accordance with Articles 6 and 7 of EU Regulation 2016/679, as well as in accordance with the provisions of **Order No. 229 of May 8, 2014** issued by the Italian Authority for Personal Data Protection, on this page the Data Controller, **PTA PAYMENT SOLUTIONS S.r.I**, with registered office in Via G. Verdi, 12 - 24121 Bergamo (BG), provides the users of this website with information on the cookies used and/or proposed for storage.

The information is valid only for the aforementioned Site and its related second and third level domains and not for other sites that may be consulted through links.

This extended information on the use of cookies (hereinafter also: cookie policy) must be acknowledged having read, in a separate document, the privacy policy, ex art. 12 EU Regulation 2016/679, which can be found in the "privacy" section of the site, at the bottom of the home page.

This cookie policy also aims to describe the elements required by law, to describe the characteristics and purposes of the cookies installed by this website, to include updated links to the notices and consent forms of third parties with which the Data Controller has entered into agreements for the installation of cookies through its website and, finally, to recall the possibility for the user to express their choices about cookies also through the settings of the browser used.

What are cookies?

Cookies are small text files that sites visited by users send to their devices. These files are stored on them to be retransmitted, at a later date, to the same sites of origin on, perhaps, a subsequent visit. Cookies can be deposited inside the user's device directly by the website the user is visiting (first party website) or by a different website, called "third party", since inside each website there can be elements (images, maps, sounds, specific links to web pages of other domains, etc.) that can be hosted and/or lead the user to links present on servers different from those providing the first party website. Thanks to the storage of cookies, the user can customize the enjoyment of certain contents of the website by saving his own preferred settings. For example, it is possible to set a cookie to recognize the user registered on the site without the user having to proceed to a new authentication during a new visit.

Taxonomy proposed by the Guarantor

(Ref. Identifying simplified modalities of information and obtaining consent for the use of cookies - May 8, 2014).

The Italian Data Protection Authority, in its Order No. 229 of May 8, 2014, proposes a taxonomy that identifies two categories of cookies based on two possible processing purposes

- 1. Technical Cookies
- 2. Profiling cookies.

Technical Cookies

They are cookies that serve to perform navigation and/or provide a service to the user. They are not used for any other purpose and are usually installed directly by the website owner. Without the use of these cookies, some operations could not be performed or would be more complex and/or less secure, such as homebanking activities (viewing account statements, bank transfers, bill payments, etc.), for which cookies are indispensable, allowing the user to be identified and maintained during the session.

Profile Cookies

These are cookies that are used to track the user's web browsing and create profiles about tastes, habits, choices, etc. These cookies can be used to send advertising messages to the user's device according to the

preferences already expressed by the user when browsing online.

User consent to the installation of cookies in the device

The expression of consent for the storage of cookies depends on the purposes for which the cookies are used and, from them, depends on whether they fall within the "technical cookies" or "profiling cookies". For the installation of technical cookies, the user's consent is not required, while in the case of third-party cookies it is necessary, among other things, to provide appropriate information (in accordance with Article 12 of EU Regulation 2016/679). On the other hand, as regards profiling cookies, they may only be installed on the user's device if the user has given free, voluntary, specific and unambiguous consent after having been adequately informed.

Analytical Cookies

The Guarantor (with reference to Order no. 229 of May 8, 2014) specified that these cookies can only be assimilated to technical cookies if they are used for site optimization purposes and directly by the owner of the site (i.e. not by a third party), which can collect information in aggregate form on the number of users and the way they visit the site.... The website uses "*Google Analytics*" cookies in an anonymous form, to collect information about the use of the website by visitors, the keywords used to reach the site, the websites visited and the origins of the traffic from which visitors come. Obtaining consent to the storage of cookies

In order to track the consent acquired, the website owner uses a special technical cookie, a system that is not particularly invasive and which, in turn, does not require further consent. In the presence of such "documentation", the brief information notice need not be repeated on the user's second visit to the site, without prejudice to the user's ability to withhold consent and/or modify, at any time and in a simple manner, his or her choices, for example by accessing the extended information notice, which must therefore be accessible from every page of the site.

Data supply

With the exception of technical cookies strictly necessary for normal navigation, the provision of data is left to the will of the data subject who decides to browse the site after having read the brief information contained in the relevant banner. Therefore, the data subject can prevent the installation of cookies by keeping the banner (thus refraining from closing it by selecting the "OK/ACCEPT" button), as well as through the appropriate functions available on his browser. Alternatively, he/she can interrupt the navigation.

How to deactivate the storage of cookies through browser settings

You can refuse general consent to the installation of any cookies on your device by selecting the appropriate settings on your browser: navigation without tracking your activities will still be available in full functionality.
